DoR - Modifications in the amended clause 5.1 (qualification of the faculty to be eligible for being granted guideship), Research Regulation - 2016 - Sanctioned - Orders issued.

<u>ORDER</u>

1). As per the reference cited 1st, the resolution of the Academic Council held on 24.09.2021 vide item No.7, to amend the Clause 5.1 of the Research Regulation-2016 regarding the qualification of faculty to be eligible for being granted guideship of the university given as (a) to (e) below, has been implemented in the University and the amendment came into effect from 24/09/2021, the date on which the Academic Council approved the amendment.

(a) Three published research papers two years prior to applying for guideship or five research papers published five years prior to applying for guideship included in the UGC CARE list/Scopus or Web of Science. Journals indexed by Thomson Reuters will also be considered.

(b) Short communication/ book reviews will not be considered.

(c) Paper presentation in three National Seminars, three years prior to applying for guideship.

(d) Presentation in one International Seminar or books published by reputed publishers with ISBN Number is desirable.

(e) After guideship is granted, if the research supervisor is not guiding any research scholars for two years, his/her guideship is liable to be cancelled.

2). The usage 'prior to' in (a) & (c) above has created ambiguity and the matter has been submitted before the Vice Chancellor for consideration and for further orders in this regard.

3). After having considered in the matters in detail, as per reference cited 2nd, sanction has been accorded by the Vice Chancellor to modify the amended clause 5.1 of Research Regulations - 2016 as furnished below :

(a) Three research papers published recently within the period of two years just before submitting the application for guideship or five research papers published recently within the period of five years just before submitting the application for guideship, included in the UGC CARE list/ Scopus or Web of Science. Journals indexed by Thomson Reuters will also be considered.

(b) Short communication/ book reviews will not be considered.

(c) Paper presentation in three National Seminars, within three years just before submitting

the application for guideship.

(d) Presentation in one International Seminar or books published by reputed publishers with ISBN Number is desirable.

(e) After guideship is granted, if the research supervisor is not guiding any research scholars for two years, his/her guideship is liable to be cancelled.
