<u>ORDER</u>

Universities have remained closed for the past several months due to COVID-19 pandemic. Therefore, the students have not been able to conduct their research/ experiments in the University laboratories nor they were able to access library services. In view of this and in larger interest of the Research Scholars, the University Grants Commission, New Delhi, as per the reference cited 1st and 2nd, has decided to extend the period of submission of thesis for six more months, in addition to the six months already granted (vide U.O. No. 4572/2020/Admn dated 15/05/2020) for M.Phil / Ph.D students, who were supposed to submit their thesis by 31st December 2020.

Accordingly, as per the reference cited 3rd, extension has been granted for the submission of M.Phil / Ph.D thesis for a period of six more months, i.e., up to 30th June 2021, to those who were supposed to submit their thesis by 31st December 2020.

University Departments & Research centres remained closed from 18th March 2020 to 31st December 2020 due to Covid -19 Pandemic and the research scholars could not carry out research during this period. After considering this, a period of nine more months' extension was granted to all research scholars, whose Ph.D. registrations were active during 18th March 2020 to 31st December 2020 as per the reference cited 4th.

As per the reference cited as 5th, extension of the period of submission of M.Phil/ Ph.D. thesis for a further period of six months beyond 30/06/2021, i.e., till 31st December 2021, was granted for M.Phil/ Ph.D students, who were supposed to submit their thesis by 30th June 2021.

As per the reference cited 6th, extension given for the submission of M.Phil/Ph.D thesis till 31st December, 2021 shall also be applicable to all such students whose due date of submission of M.Phil/Ph.D thesis is on or before 31.12.2021. However, tenure of fellowship will remain up to five year only.

As per the reference cited 7th, extension of the period of submission of M.Phil./Ph.D. thesis for six

months beyond 31-12-2021, i.e., till 30th June, 2022 - applicable to all such students whose due date of submission of M.Phil./ Ph.D. thesis is on or before 30-06-2022, was granted subject to the condition that tenure of fellowship will remain up to five years only

The University Grants Commission, New Delhi, vide reference cited as 8th, has issued a direction that an extension of up to six months, beyond 30th June 2022 may be given to the M.Phil/Ph.D students by their respective Higher Educational Institutions, on case to case basis based on the review of student's work by the Research Advisory Committee and on the recommendation of the supervisor and the Head of the Department of each individual case. Such extension may also be granted for submitting evidence of publication and presentation in two conferences. However, tenure of fellowship will remain up to five years only.

After considering the matter, as per the reference cited 9th, the Vice Chancellor has ordered to implement the UGC direction that, an extension of up to six months, beyond 30th June 2022 may be given to the M.Phil/Ph.D students by their respective Higher Educational Institutions, on case to case basis based on the review of student's work by the Research Advisory Committee and on the recommendation of the supervisor and the Head of the Department of each individual case. Such extension may also be granted for submitting evidence of publication and presentation in two conferences. However, tenure of fellowship will remain up to five years only.
