REVISED GUIDELINES FOR THE Ph.D. ADMISSION OF ANYTIME CATEGORY CANDIDATES

a. The Heads of the Research Centres/ University Research Departments should notify the vacancy of the guides on the website of the Centre/Research Department. For University Research Departments, a link of vacancy notification be given on the University Website. For University approved research centres other than the University Research Departments, the notification be limited to the College/Institution Website. The vacancy notification should include name of the guide, subject, number of vacancy, date and time of interview and the category of candidates who can apply (Any Time Category candidates only). The vacancy notification shall remain on the website for at least seven days.

b. The interview should be conducted within 20 days of vacancy notification. The eligible candidates should attend the interview on the date and time notified as per the vacancy notification.

c. The interview should be conducted as per Clause 4.10 of the Calicut University Research Regulations and a rank list should be published on the website and notice board of the Research Centre within 5 days from the date of conduct of interview.

d. After publishing the rank list, joining memo should be issued to the candidates within 7 days (Format of joining memo attached herewith). Joining Report should be issued to the candidates admitted to the Ph.D. programme.

e. CAP ID (created during the concerned admission year) is mandatory for all candidates at the time of admission.

f. The admission procedure including the conduct of RAC should be completed within 45 days from the date of joining of the candidate at the research centre. (Detailed Schedule attached herewith)

g. The admission should be granted in strict compliance with the reservation roster issued by the University vide U.O.No. 19032/2022/Admn dated 07.10.2022.

h. After the joining of the candidate in the Research Centre and conduct of RAC meeting, the proposal for issuing the final registration order should be submitted by the candidate through the ONLINE RESEARCH PORTAL. The supervisor/guide and the Head of the Research Centre should verify the details and documents entered by the candidates in the portal and forward the same to the DoR with proper certification.

i. Application along with supporting documents should be submitted to Directorate of Research within 14 days of conduct of Research Advisory Committee meeting. The DoR will issue the final registration order after verifying the details/documents forwarded by the Head of the Research Centre, granting registration from the date of joining in the research centre, if the proposal is in order.

j. Foreign Nationals may be exempted from all the above procedures and they may be admitted to Ph.D. Programme anytime during the academic year depending on the willingness/availability of guides.

2.	Conduct of interview	Within 20 days of notifying the vacancy
3.	Publication of Rank List	Within 5 days of conduct of interview
4.	Issue of Joining Memo	Within 7 days of publishing the rank list
5.	Issue of Joining Report	On admitting the candidates in the research department for Ph.D. Programme
6.	Conduct of Research Advisory Committee Meeting	Within 45 days from the date of joining of the candidates at the research centre
7.	Submission of application with supporting documents to Directorate of Research	Within 14 days of conduct of Research Advisory Committee Meeting
